Application procedure

Please send an abstract of the presentation (English or Japanese) to the JHEA Secretariat via the form for general presentation. The abstract can be downloaded from this JHEA website.

Abstract format

Please be sure to use the specified format and keep the number of words prescribed below.

In English without figure or table, no longer than 400 words including the title, the author name(s) and affiliation(s)/title(s). One figure or table can be attached. In such the case, no longer than 300 words.

Notice for applicant

- > Presentation will be given orally with power point slides or as poster session.
- > For general presentation, one person cannot submit multiple subjects as the first authors. However, there is no limit of submission as a co-author.
- Please enter two names of preferred discussants on the application form. As discussion with designated discussant is planned after your presentation. Please note that appointment of discussant will be made by the Program Committee.
- Basically, designated discussant should be a member of JHEA.
- When the presenter and co-authors are all students of graduate school, recommendation from the teacher will be required.
- Duplicate/Multiple submissions are prohibited.
